Note:

Only when there is no person with benchmark disability available for the post, the employer shall fill up the vacancy by appointment of a person, other than a person with benchmark disability, vide office memorandum dated 15.01.2018.

The person who suffers from not less than 40% of disability will only be eligible for the benefit of reservation and other relaxations under PWD category as permissible under the rule. The applicant must have a valid Disability Certificate issued from the competent authority. i.e, Medical Board duly constituted by the Central or State Government. Certificate issued by the Medical Practitioner, Hospital or any other Institution will not be considered. The Physical disability of finally selected candidates would be ascertained by a Medical Board of the Institute specifically constituted for this purpose, if deemed necessary.

- 2. Reporting place: Conference Hall, 3rd floor, ESIC Medical College & Hospital, Chennai 600 078.
- 3. The research publications are not mandatory for retired/resigned/voluntarily retired from Government or other Medical Colleges in case of their re-appointment on the same designation.
- 4. The Number of posts may increase or decrease due to administrative reasons.
- 5. The actual appointment will be subject to outcome in case of recruitment related litigations if any.
- 6. The post advertised can be upgraded/downgraded depending upon the vacancy.

- 7. Eligibility criteria and other Important Information relating to the contractual engagement is as follows:
- A. Academic qualification and teaching experience to be eligible for engagement is as per the "Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998" as amended and applicable as on date to the respective posts (Professor, Associate Professor and Assistant Professor).
- B. In case of turnout of candidates is more than the ratio of 1:20 per post, the competent authority at their own discretion may conduct a screening test to shortlist the candidates for the interview. The screening test will consist of multiple choice questions in the concerned discipline. The marks obtained in the screening test will not in any way be linked to the final selection process. The performance of the candidate in the interview will be the sole criteria for selecting the candidate for the respective post. Mere participation in the screening test will not confer any claim for the post.
 - C. Age Limit: Not exceeding 67 years as on date of reporting for interview.

D. Pay & Allowances:-

- 2. Consolidated remuneration may stand revised by 2.50% after every one year and no other allowances will be paid in addition to the consolidated remuneration.
- 3. No Private practice is allowed during the tenure of service in ESIC.
- 4. In case of engagement of retired employees/pensioners, they may be allowed to draw full consolidated remuneration without any deduction as it is not a case of re-employment in terms of Central Civil Services (Fixation of Pay of Re-employed Pensioner) Orders 1986 and retired employees/pensioners can continue to draw pension and dearness relief on pension during their period of contractual engagement.

E. <u>Terms of Contract</u>:

- (i) The contract would initially for a period of three years at the outset, with a provision of further extension for a period of two years. The maximum tenure of such engagement will not exceed 5 years or 70 years of the age of faculty, whichever is earlier.
- (ii) The contractual engagement will be subject to the following:
 - a. Barring serious misconduct/irregularity, continuation of the incumbent would be based on satisfactory annual appraisal.
 - b. The contractual engagement will be terminated giving one month notice on either side.
 - c. The incumbent would serve the initial first year of contract, independent of regular faculty joining during this period. However, the contract would be terminable on one month notice, on joining of regular faculty in the subsequent years of contract.

- (ii) Self-attested copies of certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience and Research Papers, Publications etc.
- (iii)Original certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience and Research Papers, Publications etc., should be submitted at the time of interview.
- (iv)Certificate issued by competent medical board in respect of Persons with Bench Mark Disabilities.

(H) Selection Procedure:

- (i) The selection will be made on the basis of performance of the candidate in interview before the Selection Board.
- (ii)Result will be communicated through e-mail and will be displayed on website.
- (iii) Selected candidates will have to join immediately after receipt of the offer of appointment.

(I) General Instructions:

- (i) Mere submission of application does not confer any right to the candidate to be eligible for interview unless they report on the scheduled date and time.
- (ii) Application should be submitted in the prescribed format only. The applications submitted in any other format OR incomplete applications will be summarily rejected.
- (iii) The candidates may ascertain their eligibility and report for interview on the scheduled date and time for interview. Candidates reporting after scheduled time will not be allowed to attend the interview process.
